All the members are informed that:

- The business as set forth in the Notice of AGM may be transacted through (i) voting by electronic means.
- (ii) The remote e-voting shall commence on 12th October, 2020 (9.00 AM IST) and shall end on 14th October, 2020 (5.00 PM IST) Members may note that once the votes are cast on a resolution, the members shall not be allowed to change it subsequently.
- (iv) The cut-off date for determining the eligibility to vote by remote e-voting systems at the AGM shall be 8th October, 2020.
- Any person who acquires shares of the company and become member of the (v) Company after dispatch of the notice of the AGM and holding shares as of the cut-off date i.e October 8, 2020 may obtain the login ID and password by sending a request at helpdesk.evoting@cdslindia.com.
- Members may note that-
  - (a) The remote e-voting module shall be disabled by CDSL beyond 5.00 PM. on 14.10.2020.
    - (b) The facility for voting through ballot paper shall be made available at the AGM.
    - (c) The members who have cast their vote by remote e-voting prior to the AGM may also attend the AGM but shall not be entitled to cast their vote again.
    - (d) a person whose name is recorded in the register of members or in register of beneficial owners maintained by the depositories as on the cut-off date only shall be entitled to avail facility of remote e-voting as well as voting at the AGM through ballot paper.
